LawRight is committed to developing innovative responses to unmet legal need. However severe cuts in our government funding in 2017 forced the closure or retraction of vital legal services.

Now, 1000 fewer Queenslanders receive our help – 30% of our usual number. We need to diversify our income streams to rebuild and create new services. We are looking to our closest friends to support us.

Our current under-funded priorities include our Health Justice Partnerships with the Mater Young Adults Health Centre and the Wuchopperen Aboriginal Health Service; and the Advocacy Service for the Mental Health Review Tribunal. These services increase access to justice, housing, income and legal rights and improve health and well-being.
